dormakaba Highlights Improved Integration of Keyscan Aurora Software with Milestone Video Management Systems

INDIANAPOLIS, April 10, 2024 – With today's growing concerns related to violence in schools, dormakaba's Keyscan Aurora software integration with Milestone Video Management Systems allows administrators to zoom in on events directly in real-time or after the fact based on how the technology is used. Additionally, this integration avoids the need for multiple software applications to run simultaneously.

With this integration, Keyscan Aurora can establish what's called an "Alarm Event." If a controlled door or entry/exit point is breached, Aurora will sound an alarm and automatically activate the nearest camera for observation and investigation by utilizing recording and playback. If available, Point, Tilt, Zoom (PTZ) cameras can be controlled directly from Aurora.

Another important feature is "Lockdown." With a single click using the software or three 'taps' (P3) of a card credential at any reader – a full system-wide or partial system lockdown can be activated. This means every controlled door (including those controlled by E-Plex wireless locks) is locked down and only authorized personnel can lift the lockdown.

"The ability to perform electronic identification of all persons moving throughout a controlled environment relies on innovative hardware components and the software technology to authenticate identification of an individual," said James Duff, marketing manager, at dormakaba. "The Keyscan access control systems deliver this important functionality in tandem with the Keyscan Aurora software, while being easy to purchase, quick to deploy, and simple to support."

Keyscan access control systems support any application regardless of size or complexity utilizing any combination of 1, 2, 4, or 8 door controller panels and Aurora Software.
